1.) Is this bid open strictly to carriers, or can brokers submit a response as well? **Brokers may respond to the IFB as well.** 

2.) Please provide the most recent bill for Basic AD&D including lives, volume, and premium. The census information and policy information have been provided. 3.) Is the District able to provide a census to include salary information? See District Response for Inquiry Number Two (2). Salaries above \$150,000 are capped as that is the maximum benefit amount. 4.) We were unable to locate Superintendent on census. Is Dr. Royster currently covered and if so, can the District please provide his DOB and ZIP code?

The District does not deem this information a necessity in order to complete a bid response, and therefore, will not be provided.

5.) When was the last true open enrollment on the supplemental life? **July 1, 2017.** 

6.) Please provide a detailed paid claim report.

7.) If possible, please provide annual claim counts and claim dollars for claimants who passed away as a result of COVID-19.

8.) Have there been any rate changes from 1/1/18-12/31/22 on any line of coverage? The only rate change during the specified time period was July 1, 2019. The basic life rate increased from .04 to .05.

There was a rate change during that time period effective July 1, 2019. The basic life rate increased from .04 to .05.

13.) Please provide a copy of the current Life and AD&D policy or certificate so that our proposal can match current plan provisions as closely as possible. If this isn't available, please provide the following: Plan design (benefits, maximum, guaranteed issue limits, etc.), age reduction schedule, any guaranteed issue opportunities available at annual enrollment.
