- e. provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parent involvement (Curriculum nights).
- f. provide, if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible.
- g. Invite parents to participate in training at Cherrydale Elementary School including reading, math, parenting, literacy, etc.
- h. Invite parents to eat with their children: Grandparents day, Thanksgiving, December Holiday Lunch.
- i. Invite parents to attend school events: open house, PTA, curriculum nights, book fair, health fair, success day assemblies, & 5th grade promotion.
- j. Opportunities to tour the building & observe classroom instruction.
- k. j. Opportunities for Math Night, Family Literacy night, Author's day and night, Children's book give away, and parenting workshops with parenting coordinator.
- L. Distribute Student Agendas with Parent Handbook
- m. Sign and return School Compact to affirm responsibilities of students, parents, teachers, and administrators.
- n. All information and programs for parents are available in a Language and form they can understand. For example, all parents of ESOL students receive information in English and their first language.

Responsibilities

- 1. Convene at least three Title I planning meetings each year.
- 2. Encourage parents to attend all Title I parent meetings, conferences, and workshops.
- 3. Address parental and community concerns about any school policy in a timely manner.
