Student Parking Form & Policies 2017-2018

Parking decals will be sold at Greenville High School on select dates, and **the cost is \$35.00**. Please purchase your decal during the dates posted for your individual grade level. You can select your permanently assigned and numbered space on a first come, first served basis. A numbered registered hangtag will be provided and should be placed on the rearview mirror and visible at all times.

****No decals will be issued to students with outstanding debts to the school****

Driving to school is a privilege extended to students who meet the guidelines/expectations outlined below. Violations of any parking regulations will result in fines, referrals or the suspension of parking privileges.

- If a student loses a decal, the cost of a replacement will be **\$35.00**.
- Students must park in appropriate parking spaces between white lines. Any student who parks in an unauthorized parking space will be fined **\$25.00**.
- Students will obey all traffic signals, signs, road lines, and the directions of the administrator/duty personnel in the parking lot. Failure to do so will result in fines, referrals and/or the loss of parking privileges for the remainder of the year.
- Parking lot speed limit is **5 MPH**
- After 3 parking violations, parking privileges will be revoked for 2 months. If a student receives 4 violations, their permit will be revoked for the rest of the year.
- Permits are nontransferable. Only the student who registers for the permit may use it. There will be NO refund if the student leaves school for any reason during the year or if their privilege is suspended.
- Students may not return to their vehicles during the school day without administrative approval.
- Any vehicle on school grounds is subject to search by the administration at any time.
- **NEW THIS YEAR** IF students are excessively tardy to school (more than 3 per quarter) they may have their permit revoked by administration for a period of time TBD by Administration.

Students driving or riding to DCC or FAC will need an approved application. These applications are available at DCC or FAC.

STUDENTS MUST HAVE THEIR DRIVER'S LICENSE, PROOF OF INSURANCE, VEHICLE REGISTRATION, DRIVING COURSE DOCUMENTATION (ALIVE @ 25 OR COMPARABLE), THIS FORM SIGNED BY PARENT/GUARDIAN AND STUDENT, AND \$35.00.
