### What is Title I?

Title I is a federally-funded program established to ensure that all children have a fair, equal, and significant opportunity to obtain a high-quality education and reach proficiency on challenging State academic achievement standards and state assessment.

## How is our school eligible to receive Title I funding?

Title I allocations are calculated using the 135<sup>th</sup> day enrollment and direct certification numbers. Calculations for 2019 -2020 show 61.74% poor compared to 66.72% poor in 2018 – 2019. Federal monies are assigned to the schools where decisions are made to best use the funds to impact student achievement. Federal monies at TEK provide: additional classroom teachers, an Instructional Coach, reading interventionists, an assistant for the lab, a Behavior Coach, a Parent Involvement Coordinator with resources for families through parenting sessions, classroom materials, professional development and technology licenses for Reading A-Z.

#### How can parents participate and learn ways to help their child?

Monthly parenting sessions are provided at various times to encourage parents to attend and learn how to be a partner in their child's education. *Building Readers* is a subscription that highlights important topics related to improving a child's reading. Copies are posted on the Title I webpage, as well as, sent home. Parent resources are available for checkout through the Parent Involvement Coordinator. Student agendas are sent home nightly to provide homework daily with any questions or concerns. A Suggestion Box is located in the front office for your comments. Parents are encouraged to serve on committees, volunteer, and to visit classrooms. *Classroom visits should be scheduled with the teacher in advance*. This year, there will continue to be specific classroom visitation days to encourage parents to learn more about grade-level expectations.

- Reading and Math are key components of Title I, however, Science and Social Studies have been added for accountability purposes with the approved ESEA waiver

- Affording parents substantial opportunities to participate in the education of their children
