- Provide materials for Parent and family Literacy and Resource Center housed outside the guidance office,
- Provide information about support services available to parents and families and students,
- Provide Monday Memos including month at a glance for parents and families with dates of upcoming events,
- Provide support for parents and families with students new to Monaview, • Provide teacher communication that informs parents and families about their children's academic needs and successes,

- Provide information to parents and families about upcoming programs at various community locations,
- Provide information to parents and families about the 4-K, and 5th grade program including enrollment procedures and also parent and family and family training in the transition from 4-K to K-5, 5th grade to 6th grade, and
- Provide training in the spring for parents and families about how to help their children with the transition of going to the next grade level.

D. Coordinate and integrate parent and family engagement strategies with parent and family engagement strategies under other programs such as Head Start, Reading First, Early Reading First, Even Start, Original 6 Foundation, Parents and Families as Teachers program, Home instruction Programs for Preschool Youngsters, and State-run preschool programs.
